Kashi Samvaad 2025 OVERVIEW

The Confederation of Indian Industry (CII) convened **Kashi Samvaad national summit on social development** advancing the Viksit Bharat 2047 vision in Varanasi on 21-22 November 2025.

Conceived as national forum for dialogue, collaboration, and innovation, Kashi Samvaad was organised in partnership with the Department of Social Welfare, Government of Uttar Pradesh; Banaras Hindu University (BHU); the CII Foundation and aligned with the Ministry of Electronics and Information Technology (MeitY)'s India–AI Impact Summit 2026. It brought together senior government leaders, policymakers, academicians, students, development practitioners, industry leaders, and CSR experts to deliberate on the future of inclusive development.

The objective was to:

- Create a national forum dedicated to multi-stakeholder and cross-sector discussion and collaboration for social and economic inclusion.
- Engage with academia faculty and students to sensitize them to facets of social development.
- Enable knowledge exchange on innovation-led solutions for India's development challenges.
- Deepen partnerships between Government, academia, industry, and civil society.
- Strengthen the role of CSR as a vehicle for piloting scalable, high-impact social interventions.
- Produce actionable recommendations contributing to the Viksit Bharat 2047 agenda.

The discussions spanned critical themes such as education, healthcare, livelihoods, sustainability, Al and technology, and community empowerment. Eminent speakers and practitioners shared insights on bridging gaps between policy and practice, while participants explored opportunities for partnerships that align corporate social responsibility with national development priorities.

The summit was inaugurated by **Smt Anupriya Patel**, Hon'ble Minister of State, Health & Family Welfare, Government of India, who underscored the centrality of **jan bhagidari** (people's participation) in nation building.

The event concluded with the release of the **Kashi Declaration**—a set of recommendations for social development—and the signing of an **MoU between CII and Banaras Hindu University** to advance collaborative initiatives.



KEY DISCUSSION POINTS

a) Healthcare: From Infrastructure to Impact: Experts discussed outreach to remote areas integrating Ayushman Arogya mandirs, primary and community health centres with digital telemedicine to create a new healthy India with a focus on inclusion of mothers, children and elders through community involvement.





b) Education & Skilling: Powering Futures: Themes included 21st-century learning, bridging foundational learning gaps, public–private learning models, and aligning skilling programmes with rural livelihoods.

c) Clean India, Green India & Waste Management:

Discussions focused on circular economy solutions such as composting, plastic recycling, waste-to-energy innovations, and strengthening Extended Producer Responsibility systems, along with integrating the informal sector.





d) Technology & AI for Social Transformation: Leaders from IIT BHU and corporates such as IBM, TCS and Microsoft discussed AI-enabled advancements in agriculture, manufacturing and public service delivery. Speakers emphasized inclusive design and ensuring technology reduces digital inequalities.

e) Rural Prosperity: Grassroots to Greatness: Panelists highlighted rural entrepreneurship, inclusive infrastructure, women-led development, local knowledge systems, and community-driven capacity building as essential for rural transformation.













KEY OUTCOMES

a) Release of the Kashi Declaration

A consolidated set of recommendations outlining priorities to accelerate India's inclusive development

b) MoU between CII and BHU

The partnership formalises collaborative work on research, innovation, and development initiatives aligned with inclusive growth.





c) Institutionalisation of Kashi Samvaad

Consensus emerged to develop Kashi Samvaad into an **annual national platform** for dialogue and cross-sector collaboration for social development.

d) Opportunities Identified

- CSR collaboration for health, education, skilling, environmental and other initiatives
- Joint pilot projects between industry, academia, and civil society
- Al-enabled innovations
- Strengthening community-led rural development pathways






WAY FORWARD
