We held our first flagship program, Greener Tomorrow, in June which brought together stakeholders from industry, civil society, government, academia and the farmer community to drive conversations and action on climate resilience and sustainable development.

s most parts of north India are inundated by monsoon rains, there is unpredictability and loss: intense downpours and erratic rain patterns have become increasingly common - a sign of intensifying climate change. These rains follow a period of intense heat waves, which left many natural water bodies dry across several parts of the country.

Climate change is impacting lives, livelihoods. and ecosystems profound ways. The urgency to address climate change has never been clearer.

It is against this backdrop that the CII Foundation held its first edition of Greener Tomorrow in June 2025. The program brought together stakeholders from industry, society, government, academia and the farmer community conversations and action on climate resilience and sustainable development. The need to build a future that is economically strong but also environmentally sound was stressed. A coffee table book capturing the expanse and impact of our flagship program on crop residue management was released at the program.

Continuing our focus on climate action, the CII Foundation has launched the Sundarbans Mangrove Restoration and Livelihood Generation Project in the climate-sensitive Sundarbans delta.















This initiative adopts an integrated approach—reviving fragile mangrove ecosystems while empowering women through sustainable livelihoods. In a region facing rapid sea-level rise and biodiversity loss, this project is a step towards both environmental recovery and economic resilience.

One of the key areas identified for intervention is Healthcare. As a pilot project, the CII Foundation rolled out a health systems strengthening program in Uttar Pradesh's Chandauli District with a focus on improving maternal, child and adolescent health.

Another proud milestone was the announcement of the CII Woman Exemplar Award 2025 winners. This initiative continues to spotlight extraordinary women from underserved communities who have emerged as changemakers in their fields. Twenty selected leaders convened in Gurugram for a two-day leadership development workshop, designed to build their capacity and foster collaboration. At the CII Annual Business Summit, four outstanding women were presented the Woman Exemplar Award by Smt. Annpurna Devi, Hon'ble Minister for Women and Child Development, Government of India. Their stories are not only deeply inspiring but also emblematic of the resilience and strength that lies within our communities.

Re-affirming our commitment to women's empowerment, we co-hosted a heartfelt and inspiring program on International Widows' Day. The event brought together voices from the Army Women's Welfare Association (AWWA), international partners, and women with lived experience of personal loss. The message was emphatic: widows deserve inclusion, dignity, and supportive ecosystems that recognise their unique challenges.

A defining event was the announcement of the CII Woman Exemplar Award 2025 winners. The women empowerment initiative continues to spotlight extraordinary women leaders from underserved communities who have emerged as changemakers in their fields. Twenty selected leaders convened in Gurugram for a two-day leadership development workshop, designed to build their capacity and foster collaboration.

The CII Foundation has also strengthened its work around skill development and in Maharashtra, we have inaugurated a state-of-the-art vocational training centre. Equipped with advanced lab infrastructure and an industry-aligned curriculum, the centre is designed to equip rural youth with industry-specific skills—building employability where opportunities are otherwise limited.

Across all our initiatives in the quarter, a common thread emerges; amplifying unheard voices and driving change from the ground up. We believe development is not just about delivering solutions—but about building trust, nurturing leadership, and walking the journey alongside communities.

#### **CROP RESIDUE MANAGEMENT**

orld Environment Day serves as a stark reminder that climate change is an urgent issue demanding our collective attention. Among the critical challenges we face is effective crop residue management to protect our environment and secure a sustainable future. With far-reaching consequences for air quality, public health, and soil degradation, crop residue burning continues to be a critical contributor to regional pollution and climate change. Recognising the need for scalable, sustainable solutions, the CII Foundation has been leading long-term, а community-based Crop Residue Management (CRM) initiative since 2018. What began in 19 villages in

Punjab has now expanded to over 1,000 villages across 13 districts in Punjab and Haryana.

Through a combination of awareness generation, farmer training, access to machinery, and promotion of alternative uses for stubble, the initiative focuses on shifting the perception of residue from a waste material to a resource that can improve soil health and generate income. In the April—June quarter, a key highlight was the Greener Tomorrow - CII Foundation's first flagship conference on climate action and sustainable development. Additionally, field activities were scaled up, and a strategic partnership with the Punjab Agricultural University was formalised.

#### **EXPANDING GEOGRAPHIC FOOTPRINT**

In a significant development, CII Foundation signed a Memorandum of Understanding (MoU) with Punjab Agricultural University (PAU) on 20 May 2025, to promote the "Simultaneous Sowing of Wheat While Harvesting Rice" technology — an innovative method in tackling stubble burning.

The MoU was signed in the presence of Dr. Satbir Singh Gosal, Vice-Chancellor, PAU, and Mr. Sunil Misra, CEO, CII Foundation, along with Mr. Chandrakant Pradhan, Lead - Climate Change Resilience and Mr. Tahir Hussain, Program Officer, CII Foundation.

The MoU outlines a collaborative framework under which CII Foundation will support awareness, training, and outreach activities, while PAU will offer the technical know-how, conduct field demonstrations

and fulfil participatory research component for this technology. Through this MoU, we aim to accelerate adoption of eco-friendly farming solutions like the Surface Seeder Machine that conserve soil, reduce emissions, and enhance crop productivity.



#### FIELD VISITS AND MEETINGS

CII Foundation in partnership with HDFC Bank organised a volunteer field day in Majhi village, Sangrur district on 20 May 2025. The interactive session brought together project volunteers from both states to share learnings, engage with farmers, and promote sustainable alternatives to stubble burning.

Their presence and participation are key to scaling behavioural change and building trust within farming communities. Through collective effort, this initiative continues to promote clean air, healthier ecosystems, and farmer-led climate stewardship.



#### **WORLD ENVIRONMENT DAY 2025: TREE PLANTATION DRIVES**

Marking World Environment Day 2025, a large-scale tree plantation drive was conducted in partnership with HDFC Bank across 15 villages in Ludhiana district. A total of 15 volunteers planted approximately 70 trees in the following areas:

- Khanna Block: Bija, Goh, Jarg, Jatana, Khattra, Daheru, Issru
- Jagraon Block: Sidhwan, Swaddi, Bardeke, Pabbian, Dangia, Mallah, Cheema, Lakha



The initiative aimed to enhance green cover and build environmental awareness, reinforcing community ownership of natural resources.

In a parallel effort, Goodyear India supported a tree plantation drive in Barnala district, further strengthening climate-responsive action in Punjab's agricultural regions.



# URBAN CLIMATE RESILIENCE - RESTORATION OF WATER BODIES AND TREE PLANTATION INITIATIVE

The degradation of traditional waterbodies has led to increasing water scarcity and shrinking biodiversity across rural landscapes. To address this growing concern, the CII Foundation began its waterbody restoration journey in 2023 in Chennai, Tamil Nadu. Partnering with Kemin Industries, under the CII Southern Region's Water Alliance Initiative, the Foundation successfully rejuvenated Eswaran Pond, Karuperi Kullam Pond, Panpakkam Pond in Gummudipoondi, and SR Kandigai, Thiruvallur District.

Building on this experience, the Foundation extended its efforts to Haryana with a new initiative to restore 10 waterbodies across five villages—Taj Nagar, Daboda, Basunda, Khandewla, and Hajipur—under a partnership with PTC India Financial Services Limited. By working closely with Gram Panchayats, the project is reviving local ecosystems and promoting water security.

#### **Key Components of the Program**

- · Enhancing water retention of the waterbodies
- · Cleaning clogged inlets and outlets
- Preventing further contamination of community ponds through awareness and behavioural change

Due to project interventions, several waterbodies were restored and bio-diversity greatly enhanced.

Key Achievements of Waterbody Restoration Initiative - 2024



5 waterbodies restored

Expanding on the climate resilience agenda, the CII Foundation launched a large-scale afforestation project in partnership with PTC India Financial Services Limited. As part of the Community Plantation Initiative for Carbon Offsetting, the project aims to plant 1,00,000 native saplings across five villages in the Farrukhnagar block of Gurugram district.

This collaborative initiative not only addresses carbon sequestration but also supports groundwater recharge and soil conservation, in line with broader ecosystem restoration goals.



On 5 June 2025, CII Foundation, in collaboration with PTC India Financial Services Limited, marked World Environment Day through a tree plantation drive in Daboda village, Farrukhnagar Block, Haryana. The event witnessed enthusiastic participation from school children, teachers, the Sarpanch, and local stakeholders. By restoring natural ecosystems and planting native trees, the initiative promotes groundwater recharge, biodiversity, and environmental stewardship at the village level.



#### **Environmental Impact of Season 2024**

In season 2024, 87% of the intervened land in the 793 villages was saved from stubble burning.

# GREENER TOMORROW CONFERENCE: A COLLECTIVE CALL TO CLIMATE ACTION



On 9 June 2025, CII Foundation hosted its flagship Greener Tomorrow conference at the India Habitat Centre, New Delhi. The event brought together policymakers, industry leaders, grassroots champions, academics, and civil society voices to discuss the path forward on climate resilience.

Present on the occasion were Dr. Bhaskar Chatteriee, Former Secretary, Public Sector Enterprises, Government of India; Dr. Makhan Singh Bhular, Director of Extension Education, Punjab Agricultural University, Ludhiana; Mr Asim Khan, Lead - CSR, Cadence Design Systems; Mr. Jasmeet Singh, Director, Fair Climate Fund; Mr. Rakesh Khatri. Environmental Champion, known as the India who shared their Nestman of perspectives. Dr. Chatterjee highlighted how corporate responsibility in India progressed from the belief that "charity begins at home" to a structured, board-driven mandate. "As we stand at the intersection of CSR, SDGs, and ESG, we are not just redefining business responsibilities — we are shaping the future of society. It's time to move beyond compliance, towards commitment, and build a future that is not only economically stronger, but socially just and environmentally sound".



#### **Key sessions included:**

- Collaboration to tackle stubble burning –
   A roadmap for 2025: In this session, experts from Punjab Agricultural University and farmer representatives discussed innovative techniques like Tarr-Wattar Direct Seeding of Rice and nutrient-retentive residue removal.
- Transformative Action on Ground Powered by Youth & Grassroots Leaders: This session spotlighted real-world narratives driving grassroots environmental change.
  - CII Woman Exemplar Ms. Basmati Gagrai from Jharkhand shared her journey of protecting village forests through community mobilisation. Through lived experiences in crop residue management, plastic and material recycling, and water body restoration, these stories reflected the power of youth-led innovation, local leadership, and community ownership.
- Masterclass on Village Eco-Restoration:
   This session explored a holistic approach to model village development and ecosystem restoration. Speaking at the session, Mr. Jasmeet Singh, Director, Fair

Climate Fund, India "If India is to develop, our villages must lead the way. Carbon markets offer a powerful opportunity, but companies and NGOs must step in to complete the crediting process and ensure rural communities benefit."

 Reducing plastic burden on the planet – role of community initiatives: The session focussed on dealing with the piling of plastic waste dumps. Discussion centred around number of innovative initiatives being implemented in various parts of the country. Experts including Swati Singh of GRID-Arendal highlighted the need for behaviour change and community buy-in to address plastic waste.

A highlight of the day was the launch of From Smoke to Solutions: The Zero-Burning Revolution, a coffee table book chronicling the transformative impact of CII Foundation's CRM initiative.

The event concluded with a felicitation ceremony honouring champion farmers and corporate supporters, whose commitment is driving India's climate action at the grassroots.











ndia's geographic diversity, combined with the hounting pressures of climate change, makes it highly susceptible to natural disasters—ranging from floods and cyclones to landslides and droughts. These events cause large-scale displacement, damage essential infrastructure, and disrupt livelihoods, especially for vulnerable and underserved communities.

Over the past years, the CII Foundation has responded to several humanitarian crises, including the Kerala floods (2018), Assam floods (2022), Cyclone Michaung in Tamil Nadu and Andhra Pradesh (2023), and the Wayanad landslides (2024). Through a coordinated, multi- stakeholder approach, the CII Foundation has provided immediate relief—such as food, medicine, and essential supplies—and led long-term rehabilitation efforts to rebuild schools, health facilities, and livelihoods.

#### **Key Components of the Program**

Establishing a Robust Disaster Response System using the extensive CII Network Distribution of Relief Materials such as Food, Ration, and Medicine to Affected Regions. Rehabilitation Initiatives through Reconstruction of Impacted Infrastructure like Schools and Health Centres, coupled with Livelihood Programs for Affected Communities.

# REHABILITATION EFFORTS IN WAYANAD, KERALA

In the aftermath of the floods and landslides that struck Wayanad district in July 2024, the CII Foundation joined hands with the Wayanad District Administration and Orkla India Pvt. Ltd. to implement rehabilitation programme. integrated intervention focused restoring on education infrastructure, supporting vulnerable tribal communities, and enhancing the capacity of Anganwadi Teachers.



#### Anganwadi Refurbishment in Flood-affected Areas

The Anganwadi Refurbishment Project is a focused initiative designed to upgrade the infrastructure and enhance the overall functionality of key Anganwadi Centres across Wayanad District. The project aims to strengthen early childhood care and development services by creating safer, more stimulating, and child-friendly environments. A total of 15 Anganwadis have been selected for refurbishment, spanning across 8 Grama Panchayats and 1 Municipality in Wayanad, following a detailed assessment of 21 Anganwadi Centres in consultation with the Wayanad ICDS office and Nirmithi Kendra—the official technical partner.

These Anganwadi Centres were rendered non-functional due to water damage and structural instability. The CII Foundation initiated refurbishment



of these centres to restore child-friendly learning environments using BaLA (Building as Learning Aid) concepts to create vibrant, interactive spaces for early learners.

Revised infrastructure plans and budgets were developed following joint site visits with Anganwadi teachers, Panchayat members, and ICDS supervisors.

By the end of this quarter, refurbishment work had commenced across the first set of 5 Anganwadi centres. This included civil repairs, improved water and sanitation facilities, enhanced ventilation, installation of BaLA elements, and procurement of age-appropriate elements through wall-art. Periodic quality checks were undertaken to ensure adherence to safety and design standards.

The upcoming quarter will focus on completing refurbishment for the next 10 centres, rolling out the first round of capacity-building for Anganwadi workers, and establishing monitoring and feedback mechanisms to support effective and adaptive implementation.

#### **Livelihood Support for Tribal Communities**

A key focus of the programme is to assist marginalised tribal families—particularly bonded labourers from the Paniya community. The CII Foundation in collaboration with Synthite Industries Private Limited facilitated the reconstruction of a community tribal kitchen and recreation centre at the Priyadarshini Tea Estate. This facility is envisioned as a hub for nutrition, cultural preservation, and social well-being, contributing to the long-term empowerment of tribal residents.

Together, these efforts will significantly enhance access to safe educational spaces, support income generation, and restore critical infrastructure in disaster-hit villages of Wayanad.





#### **EARLY CHILDHOOD EDUCATION**

The early years of a child's life are crucial in shaping their cognitive, emotional, and social development. Quality Early Childhood Education (ECE) not only prepares children for formal schooling but also builds the groundwork for their overall well-being and future learning outcomes.

Despite strong evidence from studies by the Centre for Early Childhood Education and Development (CECED) on the positive impact of ECE, access to quality early education remains limited across many parts of India. Addressing this gap, the CII Foundation has launched targeted interventions aimed at strengthening ECE delivery systems by engaging governments, industry partners, and grassroots organisations.

The initiative has seen impactful results in Jammu & Kashmir, while new efforts are underway in Tamil Nadu, Kerala and Andhra Pradesh with a focus on developing child-friendly, inclusive learning spaces through model Anganwadi Centres.

Infrastructure Support to Develop Model Anganwadi Centres Developing Age and Culturally Appropriate Curriculum

#### **ANGANWADI STRENGTHENING PROGRAM, TAMIL NADU**

In Tamil Nadu, the CII Foundation in collaboration with CII Southern Region and Kasa India Pvt. Ltd., is supporting early education and health interventions through the transformation of Anganwadi infrastructure.

The Kottaikarai Anganwadi in Gummudipoondi, Thiruvallur District, was selected for refurbishment with a dual focus: upgrading infrastructure and equipping Anganwadi workers with enhanced skills.

The project was formally launched in the presence of representatives from Kasa India Pvt. Ltd., officials from the ICDS Department, Government of Tamil Nadu, Anganwadi staff, and community stakeholders including parents and children—marking the beginning of a more nurturing and engaging environment for early learners.





mproving access to quality healthcare and encouraging community-driven well-being remains central to the CII Foundation's mission. Through a combination of health systems strengthening and school-based awareness initiatives, the Foundation is working to build resilient, informed communities

across rural India. Two flagship interventions in Uttar Pradesh and Haryana reflect this commitment — one focused on strengthening the health and nutrition ecosystem at the village level, and the other on nurturing health-conscious behaviour among school children.

# HEALTH SYSTEMS STRENGTHENING PROGRAM, CHANDAULI, UTTAR PRADESH

CII Foundation in collaboration with Digiswasthya Foundation is implementing a Health Systems Strengthening Program in eight villages - Sisaura Kala, Murali Pur, Mahuji, Medhana, Jigana, Visunpur Khurd, Avahi, and Vira Saray of Dhanapur Block in Chandauli district, Uttar Pradesh. The program aims to enhance the existing health and nutrition ecosystem while promoting early childhood care and education. The intervention ensures that services are accessible, efficient, and inclusive, particularly for women, children, and adolescents.

In April 2025, a Tetanus and Diphtheria (TD) vaccination drive was conducted in coordination with Health Department. Vaccinations administered at local schools with support from Nurse Midwives (ANMs), ensuring immunisation coverage among school-going children. The month also saw targeted community engagement through meetings with adolescent girls, pregnant women, and lactating mothers. These sessions focused on raising awareness about nutrition, anaemia, and the importance of daily attendance at Anganwadi centres for young children. In parallel, women's groups were mobilised to encourage school enrolment and regular attendance of older children.

Adolescent girls participated in interactive discussions on personal hygiene and were encouraged to take responsibility for escorting younger children to the Anganwadi centres. Children's groups were engaged in identifying local issues within their villages and were guided on expressing these concerns creatively through storytelling—building both awareness and communication skills.



#### HEALTH AWARENESS PROGRAM IN SCHOOLS, UTTAR PRADESH AND HARYANA

To promote early health literacy and behavioural change, CII Foundation in collaboration with HOPE Initiative has been implementing a Health Awareness Program in rural schools across Sohna, Pataudi, Manesar, Farrukhnagar, and Wazirabad in Haryana; Bindauwa, Bhaundari, Jabrauli, Bani, and Benti in Lucknow, Uttar Pradesh.

The initiative empowers school children to become health ambassadors in their communities through structured awareness sessions and experiential learning.

Throughout April 2025, schools in Mohanlalganj and Sarojini Nagar blocks of Uttar Pradesh, along with Sohna, Pataudi, Manesar, Farrukhnagar, and Wazirabad regions in Haryana, hosted sessions focused on environmental hygiene, menstrual health, balanced nutrition, and overall well-being. Special emphasis was placed on creating safe and informed spaces for adolescent girls, encouraging open dialogue and dispelling myths around menstruation.

On April 7, 2025, to mark World Health Day, the Foundation organised a theme-based awareness programme at Composite School in Jabrauli village, Mohanlalganj. Under the theme "Healthy Beginnings, Hopeful Future," over 160 students from Classes 1 to 8 participated in educational and interactive activities promoting preventive health practices.

Later in the month, Earth Day was observed on April 22, 2025, with students engaging in discussions on environmental conservation. Through vibrant poster-making sessions, they conveyed the importance of protecting trees, conserving water, and adopting sustainable practices to protect the planet.

These interventions continue to nurture awareness, inclusivity, and action-oriented community health engagement across multiple levels.





C II Foundation continues to strengthen livelihoods across India by equipping individuals—especially women and youth—with practical skills and entrepreneurial opportunities that promote financial independence and long-term resilience.

Through partnerships with industry and grassroots organisations, the Foundation is enabling communities to access dignified work and become self-sufficient.

Key Components of the Program

#### **Rural Livelihood:**

Supporting rural women through livelihood initiatives that build on local strengths—such as beekeeping, tamarind processing, and poultry farming.

#### **Skilling of Youth:**

Equipping rural and underserved youth with industry-relevant, market driven skills to enhance their employability by leveraging CII Model Career Centres and CII Multi-skill Training Centres

#### SUNDARBANS MANGROVE RESTORATION AND LIVELIHOOD GENERATION PROJECT

In the climate-vulnerable deltaic regions of Binodpur and Nagenabad (Kultali Block, South 24 Parganas, West Bengal), CII Foundation, in partnership with Joynagar Viewtech Educational Society, has launched the Sundarbans Mangrove Restoration and Livelihood Generation Project. The initiative adopts an integrated approach to restore fragile mangrove ecosystems while empowering women through sustainable livelihoods.

#### **Ecological Restoration**

Mangrove afforestation is being carried out through seedbed development, community plantation drives, and ecological fencing. By May 2025, land was allocated, seedbeds prepared and fenced, and work was underway on converting seeds to saplings and establishing potting beds. These efforts are crucial for rebuilding natural buffers against cyclones, mitigating coastal erosion, and restoring biodiversity.

#### **Livelihood Generation**

Targeting 120 women beneficiaries from nearby communities, the project delivered structured poultry training sessions, completed by 12 May 2025. In addition to technical training, the program includes mentorship and market linkages to promote sustainable income generation.

#### **Community Engagement**

From 21 March to 10 May 2025, eleven outreach camps were conducted across the region, engaging over 750 villagers. Four thematic seminars — held on 11 March, 26 March, 4 April, and 30 April — drew participation from 213 villagers and focused on topics such as cyber security, sanitation, and public health. These were organised with support from local panchayats and police departments.

By integrating climate action with livelihood security, the Sundarbans project sets an example for ecosystem restoration that is rooted in community ownership, economic empowerment, and environmental stewardship.



# BEEKEEPING INITIATIVE FOR RURAL WOMEN IN JHARKHAND

CII Foundation in collaboration with Shoshan Surin Foundation launched a beekeeping-based livelihood initiative in Gumla district, Jharkhand. On 3 and 4 April, bee boxes were distributed to participating women, laying the foundation for honey production and income generation.

The project not only creates an alternative source of livelihood but also supports biodiversity and pollination cycles vital to the region's ecology. With ongoing technical support and market linkages, the initiative is designed to help women convert beekeeping into a sustainable microenterprise, positively impacting their families and communities.



#### EMPOWERING RED CHILLI FARMERS IN BALLARI THROUGH FPO-LED INTERVENTIONS

CII Foundation, in partnership with Orkla India Pvt. Ltd. and technically anchored by CII-FACE, is undertaking impactful interventions in the red chilli value chain through Farmer Producer Organizations (FPOs) in Ballari district, Karnataka.



### Stakeholder Consultation for Value Chain Collaboration

On 17 June 2025, a Stakeholder Consultation Meeting was held in Ballari, bringing together experts, FPO leaders, scientists, and agri-business representatives to discuss strategies for a more sustainable and market-oriented chilli value chain. Hosted under the project "Strengthening Sustainability of Spices Value Chain Development through Farmer Producer Companies," the event emphasized multi-stakeholder collaboration, adoption of climate-smart practices, and leveraging government schemes.

# VOCATIONAL TRAINING CENTRE INAUGURATED IN MAHARASHTRA

On 2 May 2025, CII Foundation, in partnership with Bluestar Ltd., inaugurated a state-of-the-art vocational training centre in Wada, Maharashtra. Designed to equip young individuals with practical skills in refrigeration and air conditioning, the facility features advanced lab infrastructure, expert-led sessions, and industry-aligned curricula.

The initiative aims to bridge the gap between rural youth and the formal job market, offering them hands-on training and access to employment opportunities in the Heating, Ventilation, and Air Conditioning (HVAC) sector. With an emphasis on employability and long-term career growth, the program aspires to enhance the socioeconomic standing of participants and build a skilled workforce for the future.





#### **WOMAN EXEMPLAR PROGRAM**

The CII Foundation Woman Exemplar Program honours grassroots women leaders who are driving transformative change across Education, Health, Microenterprise, and the newly introduced category of Community Strengthening. These awards not only celebrate their contributions but also enhance the visibility and credibility of their work, opening avenues for greater support and outreach.

By equipping these women with capacity-building tools and leadership development opportunities, the program strengthens their ability to lead change at the community level. At its core, the Woman Exemplar

Program identifies, nurtures, and recognizes high-impact women leaders who hold the potential to influence systemic change.

Currently, the initiative supports a network of over 150 women leaders across India, whose efforts collectively impact more than two million lives annually. In the April—June quarter, the winners of the CII Woman Exemplar Award 2025 were announced. All 20 selected exemplars convened at the CII office in Gurugram for a two-day leadership training session designed to build their capacities and promote collaboration among exemplars.

# INTERNATIONAL WIDOW'S DAY: NOT LEAVING WIDOWS BEHIND

#### **EMPOWERING LIVES WITH OPPORTUNITY AND DIGNITY**

To mark International Widows' Day 2025, the CII Foundation, in partnership with The Loomba Foundation, hosted a special programme in New Delhi on 23 June 2025. The event brought together voices from international organisations, civil society, the Army Women's Welfare Association (AWWA), and most importantly, women and young adults with lived experience of personal loss, to spotlight the challenges widows face and underline the need for inclusive, dignified support systems.

This program builds on the momentum of Her Skill, Her Future—an initiative launched earlier this year by the CII Foundation and The Loomba Foundation in collaboration with the Women's Collective Forum. The programme aims to equip 1,00,000 widows with livelihood skills, resources, and a path to financial independence.

In her keynote address, Ms. Smriti Irani, Vice President, The Loomba Foundation, Former Union Cabinet Minister, Government of India and Chairperson and Founder, Alliance for Global Good: Gender Equity & Equality, spoke on the need for stronger systems that uphold widows' rights. "From succession rights to mental well-being, widows deserve legal clarity, systemic support, and public recognition," she said.

Mrs. Sunita Dwivedi, President, Army Women's Welfare Association (AWWA), applauded the widows for their strength and resilience and said "Rising again after life's broken pieces is something we all can learn from our brave widow sisters. You are our role models—courageous, resilient, and full of grace." She also shared initiatives by AWAA to help widows, and their dependents lead a life of dignity.

Highlighting the universal nature of the issues that widows face, Ms. Sally Taylor, Minister Counsellor - Development, Climate, Science and Technology at the British High Commission, emphasized the importance of data to ensure an equitable system that would benefit widows. "When we have gender-disaggregated data, we can create policies that are inclusive, evidence-based, and truly equitable. This is essential if we are to leave no one behind."

Bringing a personal lens to the discussion, Ms Kanta Singh, Deputy Country Representative, UN Women India, and Ms Chahavi Moodgal, Founding CEO, IIMA Endowment Fund and Advisor to the IIM Calcutta Endowment shared their lived experiences of losing their fathers and witnessing the social and other barriers their mothers struggled with.



They emphasized the need for building systems and policies that recognise the unique realities of widows to help them lead a life of dignity.

Dr Sandeep Marwah, Founder-President of the Asian Academy of Film and Television and Noida Film City spoke of the need for equity and emphasized the role of media in advancing the voices of widows, while offering his media platforms to amplify the voices. A deeply moving segment titled "Voices of Resilience: She Rises" featured stories from widows and young adults who had lost a parent. They spoke of grief, resilience, community support, and hope.

The event also included a small felicitation to honour these individuals for their courage and strength.

The programme concluded with a collective call to action, to ensure that the rights, inclusion, and dignity of widows are prioritised across policy and society.







#### **EMPOWERING COMMUNITIES FOR A GREENER TOMORROW**

apid urbanisation and population growth have placed increasing strain on local waste systems, with uncollected garbage, plastic-choked drains, and untreated waste harming both ecosystems and public health. Recognising the urgent need for intervention, the CII Foundation is implementing an integrated Waste Management initiative across multiple regions—including Farrukhnagar in Haryana, Kochi in Kerala, and Leh in Ladakh.

The programme adopts a collaborative, community-led approach tailored to local needs. It integrates awareness generation, infrastructure strengthening, and capacity building to create sustainable waste management ecosystems that protect the environment and enhance the dignity and safety of waste workers.

#### CHELODE CHELLANAM WASTE MANAGEMENT INITIATIVE, KOCHI, KERALA

In Chellanam, Kerala, CII Foundation has been working with GIC Re and the Chellanam Grama Panchayat to develop a community-led waste management model since March 2024. As part of the World Environment Day 2025 celebration, fruit saplings were planted across public spaces and schools with support from Haritha Karma Sena members and local volunteers.



The event was inaugurated by Shri K. L. Joseph, President of Chellanam Grama Panchayat, who also joined students and residents in the plantation activity. The initiative not only aims to improve green cover but also encourages long-term behavioural change around waste segregation and plastic use.



#### **WASTE MANAGEMENT INITIATIVE, LEH, LADAKH**

The CII Foundation, in partnership with HDFC Bank, has been working to strengthen waste management systems in two blocks of Leh district—Kharu and Chuchot. As part of this ongoing initiative, a large-scale clean-up drive was conducted on 5 June 2025 at Chushod Market Zampa, under the theme "Working Towards Ending Plastic Pollution."

Organised in collaboration with the Block Development Office, the drive saw enthusiastic participation from over 150 volunteers representing civil society groups, educational institutions, and local governing bodies.

The program was inaugurated by Mr. Mirza Hussain, Councillor, Chuchot, who served as Chief Guest. Also present were Shri Ghulam Mohhamed Mir, Block Development Officer, Chuchot; Mr. Nawang Thinley, Former Chairman, CII Foundation; Ms. Deskit Yangdol, Manager, HDFC Bank; Mr. Fayaz Ahmed, President, Merchants Association; Nambardars from Stok, Matho, Chuchot Yokma, and Chuchot Gongma, along with RDD staff and SRMC supervisors.



School students and teachers from Government Higher Secondary School, Chuchot Shamma; St. Peter's School; Imamia Mission School, Chuchot Yokma; and Siddhartha High School, Stok, also participated actively in the drive.

The campaign focused on plastic waste removal, awareness building on the dangers of single-use plastic, and encouraging waste segregation and responsible disposal practices—especially among local shopkeepers and market vendors.

Speakers stressed the importance of community-led solutions to tackle the plastic crisis, particularly in ecologically sensitive mountain environments like Ladakh.

As part of the initiative, certificates of appreciation were awarded to winning schools of the mural painting competition held at the Solid Resource Management Centre (SRMC), Chuchot—celebrating youth engagement and creativity in environmental action.
