Note 6: Significant Accounting Policies and Notes to Accounts

A. SIGNIFICANT ACCOUNTING POLICIES:

1. About the Entity

- a. CII Foundation is registered as a charitable Trust on 7th April 2011 with an objective to promote and facilitate ethical and socially responsible activities in the field of education, medical relief etc.
- b. The Trust has been granted registration u/s 12A and approval u/s 80G of the Income Tax Act, 1961.
- c. CII Foundation is registered under the Foreign Contribution (Regulation) Act (FCRA) having Registration No. 231661609 and obtained renewal of registration under FCRA for a further period of five years w.e.f. 16.09.2015 till 15.09.2020.

2. Accounting Convention

The financial statements have been prepared under the historical cost convention on accrual basis of accounting in accordance with the generally accepted accounting principles in India (Indian GAAP) and applicable accounting standards issued by the Institute of Chartered Accountants of India, unless otherwise stated.

3. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires CII to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosures of contingent liabilities at the date of financial statements and the reported amount of revenues and expenses during the period reported. Actual results could differ from those estimates. Any revisions to accounting estimates are recognized prospectively in current and future periods.

4. Revenue Recognition

- a. Donations are recognised as income on actual receipt basis.
- b. Interest on savings bank account is recognised on actual receipt basis.

5. Specific Activity Grants / Contributions

Specific Activity Grants / Contributions to the extent utilised are transferred to statement of income and expenditure and the balance unutilised amounts are carried over to next year in Balance Sheet for utilisation against the specific activities.

B. Notes to Accounts

1) Fixed Deposits: Rs. 460,75,451 (including Rs. 75,451/- as accrued interest) (Previous Year Rs. Nil).

2) Grants

- a) The Foundation has received total grants of Rs. 601.60 lakhs as foreign contribution in INR from subsidiaries of Foreign company during the F.Y. 2019-20 (Previous Year Rs. 25.00 lakhs as foreign contribution).
- b) No cost extension for grant utilisation period have been sought from the funding partner- "Herbalife International India Pvt. Ltd." for completion of project.
- c) Unaudited quarterly Utilisation certificate for the project i.e Social Transformation Aurangabad and Surakshit Kadhya Abhiyan have been received.
- d) Fund utilization certificate from Department of Health and Family Welfare, Government of Kerala for the NHM project will be received after completion of project.
- 3) Figure have been rounded off to the nearest rupee.

4) Impact of COVID- 19

The novel coronavirus (COVID-19) outbreak which was declared as global pandemic by the World Health Organization (WHO) on March 11, 2020 continues to spread across the globe including India resulting in significant impact on global and India's economic environment.

The Foundation has assessed the impact of COVID-19, to the best of its information, on its operations, as well its financial statements, including but not limited to the areas of revenue, costs, operational controls and processes followed, debtors and other assets, as at March 31, 2020. Based on the overall assessment, the Foundation is of the view that no additional provision needs to be created in books of account for the year ended March 31, 2020.

Further, there is no material impact on the financial statements due to the changes in the operational controls and processes followed by the Foundation during the COVID-19 pandemic situation in the country considering the lockdown implemented w.e.f. March 25, 2020. The Trust will however continue to closely monitor any material changes to the future economic conditions that may have any significant impact on its business and financial position.
